**NOTE TO PHYSICIAN:**

Inhalation exposure may include itching, sneezing and coughing. Dermal exposure may cause redness and irritation. No specific antidote available. Treat symptomatically.

**RESISTANCE WARNING:**

KICKBACK 5 GR contains a systemic, curative compound – *metalaxyl*, which belongs to the chemical group *phenylamides*. (other products from this group shows cross resistance to *metalaxyl*) Root/collar rot (*Phytophthora spp.*) in some cases are known to contain races which are resistant to fungicides belonging to *phenylamides*.

In case of apparent underperformance or unsatisfactory control by KICKBACK 5 GR programme, it is essential that the possibility of fungal resistance be considered.

In positive cases, a chemically unrelated curative fungicide should immediately substitute KICKBACK 5 GR. Consult your supplier.

To reduce selection of resistant pathogen races, DO NOT USE **KICKBACK 5 GR** FOR MORE THAN TWO CONSECUTIVE SEASONS. ALTERNATE USE WITH ANOTHER CHEMICALLY UNRELATED FUNGICIDE EVERY SECOND SEASON. (See Directions for Use Table)

Prolonged use of **KICKBACK 5 GR** on certain soil types may result in an increase of biological degradation of the active ingredient, which may lead to reduced disease control.

**NOTE:** Sub-standard application will lead to unsatisfactory control and contribute to the development of resistance.

#### **MODE OF ACTION**

**KICKBACK 5 GR** contains **metalaxyI**, which belongs to the phenylamide chemical group (FRAC group code 4) which interferes with ribonucleic acid and protein synthesis

#### **USE RESTRICTIONS:**

- Do NOT use in nurseries.
- Conditions related to gravelly, sandy soils – may result in temporary leaf chlorosis to young citrus trees.

#### **DIRECTIONS FOR USE:**

#### **USE ONLY AS DIRECTED**

- **KICKBACK 5 GR** controls *Phytophthora* and *Pythium spp.* Tree decline can also result from other causes and/or combination of factors i.e., poorly drained soils in case of Avocados, other disease and/or nematode infections in case of Citrus. Appropriate measures must be taken to rectify such non-related situations.
- Remove weeds underneath and around the tree.
- Apply product twice per season, with first application in Spring prior to rains or scheduled irrigation. It is advantageous to leach the product into the soil by means of a light irrigation after application.
- Ensure an even spread and coverage of the soil with granules within the drip area of tree foliage. If granular applicators are used, ensure that they are in good working order and correctly calibrated.
- The amount of product needed per tree can be calculated as follows:  
Measure the average distance from stem to outside line of foliage drip area in meter.  
Apply formula:  
 $r \times r \times 3.14 = \text{surface area in square meter (m}^2\text{)} \times \mathbf{40 \text{ g}} = \text{product dose per tree (in gram)}$   
( $r$  = radius = distance in m from stem to outside foliage drip line)

<b>Avocados</b> Root/Trunk rot <b><i>Phytophthora cinnamomi</i></b>	<b>40 g/m<sup>2</sup> area of soil surface</b>  (To calculate dose per tree, refer to formula above)	Apply granules evenly on soil surface within drip area of foliage canopy of tree(s). Apply treatment prior to onset of rainy season or before irrigation is scheduled. Repeat application within approx. 18 weeks. Limit initial applications to a period of 2 years, after which treatments should be alternated annually with a chemically unrelated compound.
<b>Citrus</b> Root/Collar rot <b><i>Phytophthora citrophthora</i></b>	<b>40 g/m<sup>2</sup> area of soil surface</b>  (To calculate dose per tree, refer to formula above)	Apply granules evenly on soil surface within the drip area of foliage canopy of tree(s). Apply treatment prior to onset of rainy season or before irrigation is scheduled. Repeat application within approx. 18 weeks. Apply product every alternative year. Treatments should be alternated annually with a chemically unrelated compound. In sandy, gravelly soils, KICKBACK 5 GR may cause temporary leaf chlorosis in young trees.
<b>Pineapples</b> Root/Base rot <b><i>Phytophthora cinnamomi</i></b>	<b>10-20 kg/hectare</b>	Apply granules evenly as a broadcast application on the field to be planted and incorporate to a depth of approximately 10 cm. Use the higher rate in situations with a high infection pressure. Follow up treatment 3-6 months later with foliar application of KICKBACK 700 WP (refer to label for application rate) may be necessary depending on climatic conditions.
<b>Tobacco</b> Black shank <b><i>Phytophthora nicotianae</i></b>	<b>30-40 kg/hectare</b>	Only for use on Flue Cured Varieties. Apply granules evenly on the planted ridge area and incorporate before transplanting seedlings. DO NOT use product on same fields in consecutive years.

**NOTA AAN GENEESHEER:**

Inaseming van stof mag jeuk, nies en hoes veroorsaak. Velblootstelling mag rooiheid en irritasie veroorsaak. Geen spesifieke teenmiddel is beskikbaar nie. Behandel simptomaties.

**WEERSTANDWAARSKUWING:**

KICKBACK 5 GR bevat 'n sistemiese kuratiewe verbinding *metalaksil*, wat aan die *fenielaamied* chemiese groep behoort. (ander produkte van hierdie groep toon kruisweerstand teen *metalaksil*) Wortel/stamvrot (*Phytophthora spp.*) is in sekere gebiede bekend om rasse te bevat wat weerstandbiedend is teen swamdochers wat aan die *fenielaamied*-groep behoort.

In die geval van oënskynlike onderprestasie of onbevredigende beheer met 'n KICKBACK 5 GR program, is dit nodig dat die aanwesigheid van die weerstand oorweeg word.

In positiewe gevalle behoort KICKBACK 5 GR onmiddellik vervang te word met 'n chemies onverwante, kuratiewe swamdoeder. Raadpleeg U verskaffer.

Om die seleksie van weerstandbiedende patogeenrasse te verminder, MOENIE **KICKBACK 5 GR** VIR LANGER AS TWEE OPEENVOLGENDE SEISOENE GEBRUIK NIE. WISSEL GEBRUIK AF MET 'N SWAMDOODER WAT CHEMIES NIE-VERWANT IS NIE. (Sien Gebruiksaanwysingstabel.) Aanhoudende gebruik van KICKBACK 5 GR op sekere grondtipes, mag lei tot versnelde biologiese afbreking van die aktiewe bestanddeel, wat swak siektebeheer mag meebring.  
NOTA: Ondoeltreffende toediening sal aanleiding gee tot onbevredigende beheer en die ontwikkeling van weerstand aanhelp.

#### WERKINGSMETODE:

**KICKBACK 5 GR** bevat **metalaksil** wat behoort aan die fenielaamied chemiese groep (FRAC code 4) wat inmeng met ribonukleiensuur en proteïnsintese prosesse.

#### GEBRUIKSBEPERKINGS:

- Moet NIE gebruik in kwekerye nie.
- Toestande wat verband hou met gruiserige, sanderige gronde – mag tydelike blaarvergeling veroorsaak by jong citrusbome.

#### GEBRUIKSAANWYSINGS:

#### GEBRUIK SLEGS SOOS AANGEDUI

- KICKBACK 5 GR beheer *Phytophthora* en *Pythium spp.* Agteruitgang van bome kan die gevolg wees van ander oorsake, of kombinasie van faktore nl. swak gedreineerde gronde i.g.v. Avokados, ander siektes en/of aalwurm besmetting i.g.v. Sitrus. Toepaslike maatreëls moet getref word om die nie-verwante probleme op te los.
- Verwyder onkruid onder en om die boom.
- Dien produk twee keer per seisoen toe, met eerste toediening in die Lente, voor reëns of geskeduleerde besproeiing. Dit is voordelig om die produk in die grond in te loog deur middel van 'n ligte besproeiing.
- Verseker 'n eweredige verspreiding en bedekking van die grondoppervlakte wanneer korrels toegedien word. Indien korreltoedieners gebruik word, verseker dat apparaat in goeie werkende toestand is en korrek gekalibreer is.
- Die hoeveelheid produk benodig per boom kan as volg bereken word:  
Meet die gemiddelde afstand, in meter, vanaf die stam na die buitekant van die druplyn van die blaardak van die boom.  
Pas formule toe;  
 $r \times r \times 3.14 = \text{oppervlak area in vierkante meter (m}^2\text{)} \times \mathbf{40 \text{ g}} = \text{produk dosis per boom (in gram)}$  [  $r = \text{radius} = \text{afstand in m vanaf stam tot buitenste sirkel van druplyn van blaardak.}$  ]

<b>Sitrus</b> Wortel/Stamvrot <b><i>Phytophthora citrophthora</i></b>	<b>40 g/m<sup>2</sup> area grondoppervlakte</b>  (Vir berekening van dosis per boom, verwys na formule hierbo)	Dien korrels eweredig toe op grondoppervlakte binne die drupsirkelgebied van die blaarkroon van die bome. Dien toe kort voor die reënseisoen begin of voordat besproeïng beplan word. Herhaal toediening binne ongeveer 18 weke. Gebruik produk slegs elke tweede jaar. Behandelings moet afgewissel word met nie-verwante chemiese produkte. KICKBACK 5 GR mag tydelike vergeling van blare veroorsaak by jong bome.
<b>Pynappels</b> Wortel/Stamvrot <b><i>Phytophthora cinnamomi</i></b>	<b>10-20 kg/hektaar</b>	Dien korrels eweredig toe op die oppervlak wat beplant gaan word en vermeng/inkorporeer tot 'n diepte van ongeveer 10 cm. Gebruik die hoë dosis in geval van swaar sieketedruk. Volg die behandeling 3-6 maande later op met 'n blaarbepuiting met KICKBACK 700 WP. (verwys na betrokke etiket vir toedieningshoeveelhede) afhangende van die klimaatstoestande.
<b>Tabak</b> Swartstam <b><i>Phytophthora nicotianae</i></b>	<b>30-40 kg/hektaar</b>	Slegs vir gebruik op Oonddroog Varieteite. Dien korrels eweredig toe op plantskouers en inkorporeer (meng) in grond, voordat saailinge oorgeplant word. MOET NIE die produk in opvolgende jare op dieselfde lande gebruik nie.
